2 Co-ordinator's report

- 2.1 The report had been circulated prior to the meeting.
- 2.2 There is a very exciting programme in store over the next few months.
- 2.3 Lorna has been keeping the website fresh with recent news and the current activities schedule.
- 2.4 The activities have displayed ways of staying connected in spite of everything that is going on round about us.
- 2.5 Covid 19 is widespread in the town at the moment, and care is being taken not to endanger the health of members of the group.
- 2.6 The bereavement group has emerged naturally from the Carers' Group and is proving to be a useful support to those who engage. An individual approach is often taken with the bereaved, and the co-ordinator's extra hours are proving to be very beneficial in this regard
- 2.7 The waiting list is short at the moment one daughter and her father but the ability to be fluid with members of the Group is an on-going strength of the group.
- 2.8 The Carers' Group is keen to do something to help those in need in Ukraine and a first donation has already been made to the Red Cross from funds raised by the group.
- 2.9 Plans for the art therapy sessions should proceed for this autumn. Funds have kindly been donated and received from the Co-op for this purpose.
